  - 1. Richland Township is officially asking to join with the SRTOC to form a combined Oversight Commission for both trails. He indicated that Springfield Township would also be making this request.
  - 2. The SEPTA lease is with the Townships, not the County. The County will turn the UBRT over to the Townships after the Punch List has been completed.
  - 3. The SRTOC has already set precedencies on the trail and they see no reason to reinvent the wheel. They would like to incorporate our rules, quidelines, designs, etc.
  - 4. This would also make it easier for events to be coordinated that would cross over between the two trails.
  - 5. Things to consider:
    - a) The current SRT municipalities have a legal agreement in place regarding the trail. Would this need to be modified to merge the trails? Or would the trails remain legally separate but overseen by a joint Oversight Commission?
    - b) Would the UBRT information be added to the current SRT website and Facebook pages or would UBRT maintain separate pages with links between them?
    - c) Where would meetings be held to be convenient for all?
