V. PRESENTATIONS / TRAIL BUSINESS

A. Mile Marker Status – Jeremy Macknhas photos of every ¼ mile to determine if new structures need to be added. Jeremy will share the photos, possible for volunteers like the Southern Lehigh Run Club or scouts to install. Discussed possibly adding a QR code to the mile markers to give users exact location coordinates. Peter Jarrett shared that some original trail maps exist from the railway and will try to find them.

B. Trail Updates

- i. Bridge repairs Top rails have been replaced.
- ii. E-bike misuse mitigation There is a particular group of users leaving donuts on dirt bikes in the Upper Saucon section. Police are looped in. Cris Miller mentioned that cameras will be added to the bridge over Preston Lane.
- C. Native Plant Garden Peter Jarrett shares that Maryann and the garden had a great year and a lot of help. There were roughly 30 participants at the Wildlands Conservancy Butterfly release. Maryann will be passing along her leadership role and Lower Saucon gifted her a commemorative piece. The SRTOC discussed providing a thank you lunch for her hard work.
- D. Geology Kiosks The area is cleaned. Peter Jarrett shared that two dials need to be repaired/replaced near Landis Mill Road. Peter will contact Lehigh University to replace the missing piece. Peter will take some photos of the site.
- E. Hellertown Marsh Signs Eric Bartosz shares that each panel is \$900. (+ \$350 for back panel mounting bracket if needed) Estimating sponsorship \$1,000 per sign 6 total. Eric will draft a Sponsorship request for local businesses.
